## Applications are **open**

The Better Business Support Package is part of a £20m initiative from the Government of Jersey to help employers manage the transition to a living wage. As part of this support, £5.3m has been allocated to the Better Business Grant in both 2025 and 2026 to help Jersey businesses:

- Improve productivity
- Invest in staff training
- Grow the visitor economy
- Support apprenticeships

The Better Business Grant offers up to 50% matched funding for initiatives that build skills, improve efficiency and support the visitor economy. If your business wants to invest in its future, now is the ideal time to apply.

**What it's for:** Investing in equipment, tools, or technology that helps your business operate more efficiently.

**Eligible projects include investments that lead to:**

- Improved process efficiency
- Reduced operating costs
- Increased sales

## Visitor Economy Development Grant [Read More](#) ▾

**What it's for:** Businesses that earn a significant part of their income from visitors and want to enhance their offer or services.

### Eligible projects:

- Same as Productivity Grants
- Funding is specifically ring-fenced for the visitor economy sector

**Note:** Can be used alongside other funding.

**What it's for:** Training that builds leadership, digital capability, or operational skills.

### Eligible training focuses on improving:

- Efficiency
- Cost reduction
- Sales performance

**Not covered:** Consultancy services
